**CHILD CARE PROGRAMS - 2010-2011 SCHOOL YEAR**  
**Effective September, 2010**

There is a \$35 nonrefundable registration fee for each child, which includes processing and secondary insurance for any of the following child care programs. (One fee covers all programs.) Fees are calculated for the school year. Monthly fees are the annual fee divided by ten months regardless of the number of days in a particular month. (Programs do not operate on days when schools are closed for any reason and no credit will be issued.) When schools close early, such as in-service days, the After School programs begin immediately after early dismissal, there will be no additional cost. On delayed opening of school there will be no Before Care that day. There is a one time registration fee of \$35 for all programs, September thru June. Registration fees for all programs are nonrefundable.

**BEFORE SCHOOL CHILD CARE:** (Kindergarten to grade eight)

7:15 a.m. - 8:35 a.m. Monday through Friday, when schools are in session.

315 per month includes transportation to or from the KECO program.

Children in Kindergarten at **Radburn** and **Milnes** will attend the KECO program at **Milnes School**. Children in Kindergarten at **Lyncrest**, **Warren Point**, **Westmoreland** and **Forrest** will attend the KECO program at **Forrest School**.

Children attending **AM Kindergarten** report to their home school and will be transported to their assigned KECO where they remain until 3:00 p.m.

Children attending **PM Kindergarten** report to their assigned KECO at 8:35 a.m. and will be transported to their home school for class. Parents will pick them up at 3:00 p.m.

**GENERAL INFORMATION:**

1. Monthly tuition is due the 25th of each preceding month.
2. Registration fee includes processing and secondary insurance. Only one registration fee will be charged per child, regardless of program (s) selected and are nonrefundable.
3. Enrollment in the Before or After School Programs must be for the same days each week. Any changes to your child's schedule must be in writing directly to the Community School office at least one week prior to the change.
4. A fee of \$15 per 15 minutes will be charged for late pickup of children. Late payment fees and check return fees will also be levied.
